

GIFTED GUARD CLINIC

TERMS & CONDITIONS

Effective Date: September 3, 2026

These Terms & Conditions govern registrations, purchases, participation, and use of services provided by Gifted Guard Clinic. By registering for, purchasing, or participating in a GGC program, the participant and/or parent or legal guardian agrees to these Terms.

1. Gifted Guard Clinic Programs

Gifted Guard Clinic may provide basketball clinics, camps, individual training, small-group training, skill-development sessions, specialty workouts, evaluations, basketball events, and other player-development programs. Program offerings, schedules, locations, instructors, capacity, and pricing may change.

2. Registration and Payment

Registration is not considered complete until all required registration information and applicable payment have been received. Space may be limited and registrations may be accepted on a first-come, first-served basis. Gifted Guard Clinic reserves the right to close registration when a program reaches capacity.

3. Participant Eligibility

Parents and guardians are responsible for registering athletes for an appropriate age, grade, and skill level when eligibility requirements apply. Gifted Guard Clinic reserves the right to move an athlete to a more appropriate training group when reasonably necessary for development, safety, or program operations.

4. Assumption of Risk

Basketball and athletic training involve inherent risks of injury. By participating in a Gifted Guard Clinic activity, participants and their parents or legal guardians acknowledge that participation involves physical activity and voluntarily accept the ordinary risks associated with basketball training and athletic participation.

Participants are responsible for notifying Gifted Guard Clinic staff of relevant limitations or restrictions affecting safe participation. Any separate waiver or release executed as part of registration remains applicable according to its terms.

5. Athlete Conduct

Participants are expected to respect coaches, staff, teammates, opponents, and facilities; follow coaching and safety instructions; demonstrate appropriate sportsmanship; avoid bullying, fighting, threatening behavior, or intentional disruption; and treat facilities and equipment appropriately.

Gifted Guard Clinic reserves the right to remove an athlete from a session or program for behavior that threatens safety or substantially disrupts the program. Removal for serious or repeated misconduct does not automatically entitle the participant to a refund.

6. Schedule and Location Changes

Gifted Guard Clinic may modify program dates, times, coaches, training formats, or locations when reasonably necessary because of facility availability, weather, scheduling conflicts, enrollment, emergencies, or circumstances outside our control. We will make reasonable efforts to notify registered families of significant changes.

7. Cancellations by Gifted Guard Clinic

If Gifted Guard Clinic cancels a session, we may provide, as appropriate, a rescheduled session, transfer to another available session, account credit, or a refund when Gifted Guard Clinic determines that rescheduling or credit is not reasonably available.

8. Participant Cancellations

Participant cancellations, missed sessions, scheduling conflicts, illness, transportation issues, vacations, school activities, team obligations, or changes of plans are governed by the Gifted Guard Clinic Refund & Cancellation Policy.

9. SMS/Text Message Terms

By voluntarily opting in to Gifted Guard Clinic SMS communications, you consent to receive recurring text messages regarding programs, training opportunities, registrations, schedules, reminders, announcements, and promotional offers. Message frequency varies. Message and data rates may apply.

Consent to receive marketing texts is not a condition of purchase. Reply **STOP** to opt out. Reply **HELP** for assistance.

10. Email Communications

By providing an email address during registration, you authorize Gifted Guard Clinic to send transactional communications reasonably related to your registration or participation. Marketing emails may provide an opportunity to unsubscribe from future promotional communications.

11. Photography and Media

When a participant or parent/guardian separately grants media permission during registration, Gifted Guard Clinic may use approved photographs or video from activities for promotional, educational, website, social-media, or program-related purposes consistent with that authorization.

12. Personal Property

Participants are responsible for their personal belongings. To the extent permitted by law, Gifted Guard Clinic is not responsible for lost, stolen, misplaced, or damaged personal property unless otherwise required by applicable law.

13. Facility Rules

Participants and spectators must follow rules established by facilities used for Gifted Guard Clinic programs. Gifted Guard Clinic may use third-party gyms, schools, recreation centers, and training facilities. Use of those facilities does not necessarily imply sponsorship or endorsement of Gifted Guard Clinic by the facility.

14. Website Use

Content appearing on Gifted Guard Clinic websites, registration pages, graphics, training materials, branding, program descriptions, and other materials may be owned by or licensed to Gifted Guard Clinic. Users may not reproduce or commercially exploit protected Gifted Guard Clinic materials without authorization.

15. Privacy

Use of personal information is governed by the Gifted Guard Clinic Privacy Policy.

16. Refund Policy

All registrations and purchases are subject to the Gifted Guard Clinic Refund & Cancellation Policy. By completing a purchase, the customer acknowledges that they had an opportunity to review the applicable refund terms.

17. Changes to These Terms

Gifted Guard Clinic may update these Terms periodically. The version applicable to a transaction or registration will generally be the version in effect at the time of that transaction unless applicable law requires otherwise.

18. Governing Law

These Terms will be governed by applicable laws of the State of Texas, without regard to conflict-of-law principles, except where federal law or another applicable law controls.
