

GIFTED GUARD CLINIC

PRIVACY POLICY

Effective Date: September 3, 2026

Gifted Guard Clinic (“GGC,” “we,” “our,” or “us”) respects the privacy of our athletes, parents, guardians, customers, and website visitors. This policy explains how we collect, use, protect, and disclose information.

1. Information We Collect

We may collect information that you voluntarily provide to us, including:

- Parent or guardian name
- Athlete name
- Athlete age and/or grade
- Email address
- Mobile phone number
- Emergency contact information
- Basketball-related information
- Registration and participation information
- Payment and transaction information
- Communications submitted to Gifted Guard Clinic
- Other information necessary to administer our programs

Payment information may be processed by third-party payment processors. Gifted Guard Clinic may not directly store complete credit or debit card information when payments are processed through a third-party provider.

2. How We Use Information

We may use collected information to process registrations and payments; manage clinics, camps, workouts, training sessions, and other programs; communicate with athletes, parents, and guardians; send confirmations, reminders, schedule or location updates; respond to customer-service requests; provide information about upcoming programs; improve our services; maintain business records; protect participant safety; and comply with applicable law.

3. SMS/Text Messaging

If you voluntarily opt in to receive text messages from Gifted Guard Clinic, we may send recurring SMS messages regarding training opportunities, clinics and camps, registration, scheduling and location updates, program reminders, event information, promotional offers, and announcements.

Message frequency varies. Message and data rates may apply. Consent to receive marketing text messages is not a condition of purchasing or participating in a Gifted Guard Clinic program.

You may opt out at any time by replying **STOP**. Reply **HELP** for assistance. After opting out, you may receive a final confirmation message.

4. SMS Data and Mobile Information

Gifted Guard Clinic does not sell mobile phone numbers or SMS opt-in consent information. Mobile information and SMS consent information will not be shared with third parties or affiliates for their own marketing or promotional purposes.

We may provide information to service providers that assist us in operating our messaging program, website, registration system, payment processing, or other business operations, solely as reasonably necessary to provide those services on our behalf.

5. Sharing of Information

Gifted Guard Clinic does not sell personal information for monetary compensation. We may share information with trusted service providers when reasonably necessary to operate our business, including registration, payment processing, website hosting, email and SMS communications, scheduling, customer management, accounting, and administration.

We may also disclose information when required by law or when reasonably necessary to protect Gifted Guard Clinic, our participants, customers, staff, or others.

6. Information Concerning Youth Athletes

Gifted Guard Clinic provides basketball programs that may involve athletes under age 18. Parents or legal guardians should complete registrations and provide personal information for minor participants when required.

We do not knowingly seek to collect personal information directly online from children under 13 without appropriate parental or guardian involvement or authorization. If you believe a child has submitted personal information without appropriate authorization, please contact Gifted Guard Clinic.

7. Photography and Video

Gifted Guard Clinic may separately request permission to photograph or record athletes participating in clinics, camps, training sessions, or events for legitimate program, promotional, educational, website, or social-media purposes. Any applicable media authorization presented during registration will govern the use of those materials.

8. Data Security

We use reasonable administrative and technical measures intended to protect personal information. However, no internet transmission, electronic communication, or electronic storage system can be guaranteed to be completely secure.

9. Your Choices

You may contact Gifted Guard Clinic to request that we update or correct certain personal information associated with you or your athlete. You may unsubscribe from marketing emails using the unsubscribe option provided in applicable emails. For SMS messages, reply **STOP** to opt out.

10. Third-Party Services

Our website or registration process may contain links to or integrations with third-party websites and services. Those third parties maintain their own privacy practices, and Gifted Guard Clinic is not responsible for their independent privacy policies or practices.

11. Changes to This Privacy Policy

Gifted Guard Clinic may update this Privacy Policy periodically. Updates will become effective when the revised policy is posted, unless otherwise stated.
